Regular Meeting  
September 14, 2016

Supervisor Lauwers called the meeting to order at 7:30 p.m. Mike Lauwers (Supervisor), Sheila McDonald (Clerk), Marsha Libkie (Treasurer) and Monica Standel (Trustee) and Bruce Downey (Trustee) were present. Nine guests were present.

Terry and Harold Burns were present to question the progress of a zoning ordinance violation on Miller Road.

Roger Yost was present to dispute a citation that was issued to him for blight. The zoning enforcer is out of town so the board decided to table any action until next month's meeting.

John Donnellon was present representing the Village of Emmett Multi-purpose Court Project asking if Mussey Township would be willing to donate funds towards the project. A motion was made by Libkie and supported by Downey to pledge \$2000 towards the project to be donated when the project is breaking ground. Unanimous vote. Motion carried.

A motion was made by Standel and supported by Libkie to approve the August 10<sup>th</sup> minutes as presented. Unanimous vote. Motion carried.

A motion was made by Standel and supported by Libkie to have the zoning enforcer look into an ordinance violation on Miller Road. Unanimous vote. Motion carried.

**Building Department:** Report submitted.

**Capac Youth Sports Committee:** Supervisor Lauwers received an estimate of \$25,000 to have the walking paths at the pavilion area paved. A discussion was also held about possible installation of bathrooms.

**Cemetery Board:** No meeting. Trustee Standel will be having the Capac cemetery sprayed this fall and she is looking into having signs installed at Pine and Evangelical cemeteries.

**Clerk's Report:** A motion was made by Downey and supported by Standel to pay the September bills (General Fund Ck #94700-94741 Fire Fund Ck# 7591-7610) and Bond Fund (Ck#2174-2175) with the addition of paying the Robert Kruger \$1729.22 for repairs, Allenton Collission \$45.41 and Moore Medical \$354.58 each. Unanimous vote. Motion carried.

**Planning Commission Report:** A motion was made by Lauwers and supported by Standel to appoint Mary Klug to a 3 year planning commission term. Unanimous vote. Motion carried. Minutes were submitted.

**Treasurers Report:** A motion was made by Downey and supported by Standel to accept the treasurer's report as presented. Unanimous vote. Motion carried.
